I am, by direction, to inform that applications are invited from the eligible Faculty Members (who have declared their probation) for promotion under UGC- Career Advancement Scheme from Assistant Professor Stage I to II, Assistant Professor Stage II to III, Assistant Professor to Associate Professor (Stage-IV), Associate Professor to Professor (Stage V) and Professor to Senior Professor (Stage VI) in the prescribed application format **on or before 16.07.2021**. The Faculty Members those who will become eligible within next three months after the last date (i.e.31.10.2021) may also apply if he/she fulfils all eligibility requirements under Career Advancement Scheme.

The eligibility conditions for award of promotion under CAS stipulated in the G.O. (Ms) No.5, dated 11.01.2021 of Tamil Nadu as follows:

- (1) The faculty members who have qualified and their due date for promotion under CAS falls on or before 17.07.2018, the API and other conditions may be followed as stipulated in the UGC Regulations, 2010 (4<sup>th</sup> Amendment dated 11.07.2016).

- (2) The faculty members who have qualified and their due date for promotion under CAS falls on or after 18.07.2018, but within a short period of 3 months i.e., upto 17.10.2018, to avoid hardship may exercise an option of having either the conditions stipulated in UGC Regulations 2010 (4<sup>th</sup> Amendment dated 11.07.2016) or the conditions as stipulated in UGC Regulations 2018 dated 18.07.2018.
- (3) The faculty members who have qualified and their due date for promotion under CAS falls on or after 18.10.2018, the API and other conditions will be followed as per UGC Regulations 2018 dated 18.07.2018.
- (4) The effective date of monitory benefit will be informed in due course.

The prescribed application format and eligibility condition can be downloaded from the University Website under "**CAS Promotion – July 2021**". Further, it is requested to submit the hardcopies of the application to the Registrar, Bharathiar University as mentioned below.

If annexure are enclosed in the application, kindly make page numbers, mention the page numbers in the index and also abstract of API scores for the assessment period) along with relevant supportive documents.

The applications received from the eligible faculty members will be considered for promotion under Career Advancement Scheme in accordance with the norms prescribed by the UGC Guidelines cited under reference (4) & (6) and G.O.Ms.No.350 of Higher Education (H1) Department, dated 09.09.2009 & Tamil Nadu G.O.Ms. No.5, Higher Education (H1) Department, dated 11.01.2021.

**The faculty members are also requested to specify the audit objections/DVAC, if any, pending or not. The University will consider the application of the candidates who are not referred under any audit/DVAC objections.**
