**NOTIFICATION**

**ELECTION TO THE SENATE FROM THE REGISTERED GRADUATES IN THE  
REVENUE DISTRICTS OF COIMBATORE, ERODE, TIRUPPUR AND NILGIRIS**

The Senate of the Bharathiar University is being constituted as per the Section 20 of the Bharathiar University Act 1981. The Senate comprises among others, two members elected by the Registered Graduates from among themselves, in each of the Revenue Districts of Coimbatore, Erode, Tiruppur and Nilgiris within the University area.

In this connection, nominations are invited in the prescribed form from the Graduates who have got themselves registered in the Register of Graduates maintained for each District in the University office.

The form of Nomination paper can be obtained from the Registrar on requisition with a self-addressed stamped envelope (Rs.10/-) or in person. The electoral roll relating to the Registered Graduates for each district is available for verification in the University Office. The revised Electoral Roll of each district as on April 2017 will be available **from 07.08.2017 to 22.08.2017**. The Electoral Roll of each district can be had from the University Office **on payment of Rs.150/- for each in the form of Compact Disc**. Only such of those graduates whose names are found in the electoral Roll are entitled to participate in the election.

Nomination papers shall be enclosed in an envelope superscribed "Nomination for Election to the Senate from the Registered Graduates" and sent by Registered Post with A/D, so as to reach the Registrar within the date and hour fixed. The programme schedule of the Election is enclosed herewith for information.

\* If the number of candidates nominated is equal to the number of vacancies to be filled, the Returning Officer may declare on the last date and hour fixed for the scrutiny of nomination, such candidates duly elected.

# In the event of poll becoming necessary, the method of postal voting with the option to deposit the envelope in the ballot box kept at the office of the Returning Officer shall be adopted.
