ELECTION TO THE SYNDICATE FROM THE SENATE IN RESPECT OF THE FOLLOWING CATEGORIES WILL BE HELD ON 10.01.2018.

1. **TWO MEMBERS TO BE ELECTED** by the Principals (those who are the Senate members) of affiliated Colleges from among themselves in accordance with the System of proportional representation, by means of single transferable vote.
2. **TWO MEMBERS TO BE ELECTED** by teachers of affiliated Colleges other than Principals, from among themselves, who are members of the Senate in accordance with the system of proportional representation by means of a single transferable vote.
3. **ONE MEMBER** from among Senate members not falling under the above categories and University teachers who are members of the Senate, to be elected by the Senate.

In this connection, nominations are invited to elect Syndicate members from the above said categories. The form of Nomination paper can be obtained from the Registrar on requisition with a self-addressed stamped envelope (Rs.10/-) or in person.

The list of electoral roll can be had from the University Registrar's Office on payment of Rs.150/-

Nomination form shall be presented to the Registrar, by Registered Post shall be enclosed in an envelope superscribed "Nomination for Election to the Syndicate among Senate members" or in person or by messenger during the office hours on or before the dates and hours fixed.
