The Context

The COVID-19 pandemic that has affected the world since December 2019 is the biggest challenge today, especially, in the areas of health and well-being. Many International bodies like the International Labour Organization, World Bank, and United Nations Development Programme have predicted a slowdown in growth of economies across countries, along with rise of unemployment, loss of income, increased problems of migrants, children and the elderly. The United Nations and United Nations Women have reported that lockdown, quarantine and job loss during this pandemic have led to an increase in gender inequality. This pandemic also exposes the health inequities and structural weakness of health systems of different countries. Along with these, various reports about climate change have also linked pandemics with zoonotic diseases. COVID-19 is considered one such zoonotic disease and more such diseases are predicted in the future. It has also been noticed that the Corporate Social Responsibility (CSR) funding and funding aids from International bodies have drastically reduced due to the pandemic, as well as a constraint is found in direct aid and field-based activities. This will either slow down or bring to a standstill development activities, social work and public health related projects that address inequality. Such scenarios call for a reorientation of helping professions, including Social Work and Public Health. Such a reorientation and paradigm shift will be necessary to address inequality and livelihood issues in the post COVID 19 era.

The Projects

The proposed projects/ initiatives are a few proactive intellectual responses addressing issues in the context mentioned above. The international virtual symposium aims to expose the problems, explore the responses, and endeavor to identify new emerging paradigms. The Book project is a continuation of this symposium and it invites the intellectual community (both academic/ practitioners) to reflect upon the reality, consider impacts and come up with innovative solutions. This will eventually lead to further research collaborations and create joint researches with trans or inter-disciplinary approaches.

The Objectives

The International symposium and the book project have the following objectives:

Full Length Paper Submission

Final and completed papers may be submitted after the abstracts have been accepted by the editors. A few guidelines are in place at the time of submission:

- ž The paper should be written in English (UK) and should not exceed 6000 words.
- ž It should be original, unpublished, and should not have been copyrighted. It should not have been presented or accepted for presentation at professional meetings and should not be currently under review for presentation at other professional meetings. A declaration to this effect must accompany the final paper, which must include ethical responsibilities and Standards as well.
- ž The manuscript should include a separate page containing the following in the order mentioned: title, authors, affiliation, abstract, keywords, main text, acknowledgements, appendix and references.

- ž The title page should be concise and informative and should include: the name(s) of the author(s), institutional affiliation(s), addresses of the author(s), E-mail, contact address, and telephone number(s) of the corresponding author.
- ž Authors are requested to submit a Camera-ready paper following the prescribed guidelines (see below).
- ž Authors should take responsibility of Content-Editing, Grammar-check, Proof-reading, formatting etc.
- ž The completed paper may be submitted in Microsoft Word (doc format only) on or before **15 January 2021** via email to panneersigamani@gmail.com
- ž The manuscript preparation should be adhered to while preparing the final paper:
 - Papers must be typed in Microsoft Word with doc format ONLY.
 - Text Format: Normal plain font (e.g., 12-point Times Roman), 1.5 spaced (single-spaced for indented material, notes and references). Margins must be of 1 inch on all sides. A4 size
 - Heading format: All headings including title should be 12 in Times New Roman.
 - Use italics for emphasis.
 - All photographs, charts and diagrams are to be referred to as “Figures” and should be numbered consecutively in the order to which they are referred in the text.
 - List of references must be arranged in alphabetical order. (As per APA format- version 7: <https://apastyle.apa.org/style-grammar-guidelines/paper-format>)
 - Use automatic page numbering function to number the pages.
 - Use tab stops or other commands for indents, not the space bar.
 - Use the table function, not spreadsheets, to make tables. .3
